Mitzi Barnes – Treasurer's report, New membership is down. We paid out our regular expenses and are less negative than we were in May

Mitzi Barnes – Office Report, We received 154 new memberships. We currently have 700 memberships and this time last year had 838. All cards have been sent out for applications received. All race results that have been received have been posted.

Justin Story – MX Chairman. There have been quite a few cancellations due to the weather. TCMC cancelled after signup due to there being a low turnout. This upset some riders. Turnouts have varied AMS 152, COCR 86, DMC 192, New Vienna cancelled, May 30 AMS 334, AMS 203. Dirt Country cancelled their race and are rescheduling against Lake Bailee on 8/14. It will not pay D11 points. .

GP – COCR had GP it rained. No turnout was cancelled. Action Sports and Hocking Valley also had GP's turnouts low.

Old Business:

Thrills in the Hill Committee met. Gate fee is to be \$10.00 for 12 and up. \$5.00 for 5 to 12 yrs. old unless competing. MX signup 1<sup>st</sup> class \$25.00 additional classes for same rider \$15.00. Pro classes \$30.00 signup and 100% pro pay back. GP fees same as MX. Harescramble will be \$25.00 per class. Dennis to check on getting Monster Energy drink as a sponsor. Trophy Sponsors to be on plaques and T-shirts. Deadline is 9/15/11. Will pay out 5 places for all awards.

Jayne has been talking to riders and feels they are put off about D-11 clubs & promoters fussing among themselves. We currently have 700 members was decided to send this issue only to current members.

New Business:

As treasurer, Mitzi feels we are in financial trouble and unless we do something to bring in more money or cut some of our expenses we are not going to exist much longer. Only way to bring in more money is to raise fees, which hasn't been done for a very long time. Only thing we could cut as far as expenses is the newsletter. Memberships are down and the district has to cover more and more of the cost of getting it out. Mitzi made a motion to raise fees and it was discussed but not sure from Mary's note taking if it was voted on. Some felt if we raised fees riders and clubs would drop out of district and run outlaw only. Only other solution is to reduce newsletter cost and Jayne has checked on it and didn't come up with any cheaper solutions yet. Jayne questioned if we should do away with next issue. We can't because we need to get year- end proposals in it. Jayne and Mary will do some more checking for affordable printing.

Mitzi made a motion to give each class the same amount of money (per class) like we use to do for year- end awards starting with award banquets for 2011 season. Mary 2<sup>nd</sup> motion. Voted on and 5 for and 1 against.

Justin presented a proposal submitted by Rick and Brandon Leist. It was decided the proposal is against AMA guidelines and therefore we cannot enforce it and it was not accepted.

Janet Fout made a motion to adjourn, second by Justin Story
