Sheryl Blum, Secretary read the minutes of the previous meeting. With the following corrections: 1107 Memberships sold this year. Down from last year 1574. Dan Knecht made a motion to approve the minutes as corrected. Bill Barnes seconded the motion.

Treasurers report was given by Mitzi Barnes. Total Income year to date \$38,564.04, Expenses year to date \$54,955.41, Net Income (-\$16,391.37).

Office Manager - Mitzi 1174 memberships sold this year. Down from 1600 last year. In 2009 we had 2,094. We have 1 additional sponsor for TITH.

Dirt Track - Art Pickleheimer reported there was a race in Circleville on the 13<sup>th</sup> and 14<sup>th</sup> with over 100 riders.

Hill climb - Ruth Hughes reported that she had a real good turnout for the September hill climb.

Hare scramble - Sybil Hunter absent, Dan Knecht reported a rider advanced himself at an outlaw race and wanted to move back before Loretta Lynn's .

MX: Justin Story reported there were 87 riders at Thrills in the Hills, Chillitown had 213 on Saturday and 208 on Sunday. The incident at Hilliard there is nothing back from the AMA yet.

Road - Mary Hamilton nothing much going on.

Road Congress - New event has been approved by the AMA "Club Grand Tour" this will go under one sanction and one insurance..

ATV Congress - Bill Kaepfner - The Motorized Recreation Park is official. Burr Oak State Park will be an activity park and have connectors to the Wayne for cabins, boating etc.

Offroad rule book is in process.

Offroad Congress - Dan Knecht - Homologation rule changed this year. There has to be 10 bikes built for inspection with intent to sell 100. The change requires a submission of specs, part list and 10 for inspection with 65 for sale at dealers.

Girls class rules changed for 9-12 years old and 12 - 16 year olds.

There is an automatic 1 year suspension if a rider refuses a protest tear down. Used to be a DQ for the current race.

50% race completion clarified for scoring purposes.

Advancement points will now include race results of Loretta Lynn's, Mini O's Ponca City, etc.
